**STOREY COUNTY SCHOOL DISTRICT BOARD OF TRUSTEES
FULL TIME ATTENDANCE**

The Board of Trustees of Storey County School District recognizes that full time attendance by students is a desirable goal and one that reflects the wishes of the community. The Board commits to provide a program of education for all students.

Recognizing these factors, the Board of Trustees commits to a policy of full time attendance for all students.

The following exceptions to this policy are:

1. Students who are attending classes at an approved educational institution other than Storey County School District.
2. Seniors:
 - a. on track for graduation
 - b. having a two (2) credit cushion with respect to their graduation requirements
 - c. maintaining passing grades during the two semesters prior to the semester for which they are requesting part time attendance
 - d. Having a cumulative overall GPA of 2.5 or better
 - e. Having the approval of their parents or over 18 years of age
 - f. Having the approval of the High School Site Administrator (or his designee) and the Counselor
3. Must work to provide additional support for their family

Students wishing to apply for less than fulltime attendance shall complete the attached application at least ten (10) school days in advance of the request and submit it to the ~~High School~~ Site Administrator. The Site Administrator shall make a decision on the request after discussing the matter with the requesting student and his/her parent(s)/or legal guardian(s). Students and their parent(s)/guardian(s) have the right to appeal the Site Administrator's decision to the Superintendent and, if necessary, the Board.
